## 1 Opening (presence, absence, apologies)

Christof Timpe (CT) (chairman) opens the meeting, welcomes all attendees to this open discussion (i.e. no decision making) which gives all attendees an opportunity to discuss common topics.

The agenda was presented by CT and agreed (*see < AIB -2012-MC05-01 Agenda\_v4.pdf>*)

## 2 RE-DISS Best Practice - what is the status? How to improve?

### 2.1. Continuation of RE-DISS and ensuring residual mixes continue to be published

*(see paper <AIB-2012-MC05-02 - Follow up to RE-DISS.pdf> and presentation <AIB-2012-MC05-04 - RE-DISS Status>)* (due to a technical error the paper was not disseminated to RECS members before the meeting)

*Attached to these minutes (see Annex last page) is a list of countries which provided letters of support to the RE-DISS II proposal.*

Diane Lescot presents the EU-funded research-project RE-DISS on behalf of RE-DISS team and invites all attendees to comment the Best Practice Recommendations (BPR) ([http://www.reliable-disclosure.org/upload/126-RE-DISS\\_Best\\_Practice\\_v13.pdf](http://www.reliable-disclosure.org/upload/126-RE-DISS_Best_Practice_v13.pdf))

A proposal for a RE-DISS II project was applied to the IEE- programme (RE-DISS ends in 10/2012). If this project will be funded RE-DISS II could start in March or April 2013, which would be right in time for the calculations of residual mixes for 2012. A fall back option is needed for the case that the project is not funded by the Commission, but can be developed when we know about the funding decision (in November 2012).

Comments and questions from RECS International:

- RECS-I strongly supports RE-DISS and the proposed RE-DISS II project.
- The Greenhouse Gas Protocol for Scope II carbon accounting will refer to RE-DISS and EPED with regard to the residual mix calculations. RECS thinks that this calls for a higher degree of transparency on the methodology used. Specifically in regards to increasing the carbon calculation transparency
- RECS also suggests full access for stakeholders to the data relating to the Residual Mix calculations. This would give more credibility to the results and would be adequate in the light of the public funding of the project.
- Market players wish for a more important role/inclusion in the RE-DISS project.

A: Transparency: The Residual Mix methodology is described in publicly available documents.

A: Full access to data: CT and DL are reluctant to offer this. The Competent Bodies supply figures for the RE-DISS calculation of Residual Mixes and might oppose to publishing these figures, as some details might be confidential. RE-DISS is only partly funded by the Commission. Although all results are published, the intellectual property on the background data remains with the project team.

A: Involvement of market players: The main target group of the current RE-DISS project are Competent Bodies. RE-DISS team is very willing to increase the transparency but the teams' experience shows that Competent Bodies have much more open discussions without Market Players being present. The RE-DISS II proposal contains a conference with Market Players. The details of transparency will depend as well on the Performance criteria defined by the IEE-agency in the project contract.

Q: How could the BPR be transformed into legislation?

A: On the RE-DISS website country profiles are available which explain how the BPR is implemented and give recommendations for improvements. RE-DISS is monitoring this for the countries. But RE-DISS cannot enforce its recommendations on any countries because it is a consultancy-project. However, Market Players could consider in which way they could contribute to support the outcomes of RE-DISS on a European level, e.g. by putting pressure on the national competent bodies.

Q: There should be more pressure put from the RE-DISS project on how to implement disclosure in a coordinated way. EU Commission could be consulted how implementation could work

A: RE-DISS is not providing binding recommendations on disclosure. However, RE-DISS will propose new Commission guidelines to Member States on the implementation of disclosure.

Comment from Michael Lenzen (on behalf of CertiQ): RECS members could voice their interest that Portugal and Spain use the BPR.

### 3 Any other Business

Q: What about the monthly statistics?

A: Phil Moody is working on this, but cannot release the new data because of the results in the new calculations still need to be verified. AIB GM will be asked on the day following the MC to support the general structure, which is a fundamental change.

Q: Any news on implementation of GO-system in Portugal?

A: New registries are installed in Spain and Portugal since end of April 2012. Portugal is currently in a difficult situation mainly due to problems to finance any action regarding this. And it is also difficult to proceed if there is no market for GOs in some countries. Maybe it would be an idea to have a service provider for operating the registries in these countries on a transaction-based fee structure? A joint action from AIB and RECS support these countries.

### 4 Ex-domain cancellation

*Oral presentation by Rolf Jorgensen*

Rules for Ex-domain cancellation are very straightforward. In fact one cannot do such cancellations within the EECs system except in the case that there are temporary malfunctions in the connection between registries. A solution for countries which are currently not electronically connected will be provided by AIB through its "non member hub service".

## 5 Expiry of EECS ICS certificates

*Oral presentation by Rolf Jorgensen*

Expiry of a GO is governed by domain specific rules (EU-Directive is not detailed enough in this and leaves space for interpretation by each country/domain).

In case that a GO and an ICS are linked, they will expire together.

ICS only certificates (like RECS certificates) have no expiry date. Participants agreed that it would make sense to remove "old" RECS certificates from the registries. However, this would have to be done by the account holders. AIB members cannot enforce this.
